

**Evolve Entertainment on behalf of Video Ezy Australasia Pty Ltd (Video Ezy)**  
**Month of Free Rentals Competition (February 2020) Competition**  
**Terms and Conditions**

1. This is a game of chance, wherein the winning entry is selected at random by Gleam, and skill plays no part in selecting the winner.
2. Information on how to enter forms part of the Terms and Conditions of entry. Entry into the 'Month of Free Rentals Competition (February 2020)' Competition (the Competition) is deemed acceptance of these Terms and Conditions of entry.
3. Entry is open to Australian residents of Western Australia, Northern Territory, Queensland, Victoria, South Australia, Australian Capital Territory and Tasmania, who must be 13 years of age and over (*Eligible Entrant*). Residents of New South Wales are not eligible to enter. Entrants under the age of 18 must provide contact details for a parent or guardian. However, business directors, management and employees, their immediate families, their retailers, suppliers, associated companies and agencies of Evolve Entertainment and Video Ezy Australasia Pty Ltd are not eligible to enter.
4. The Competition commences on at 12:00AM 01/02/2020 (AEDT) and concludes at 5:00PM 29/02/2020 (AEDT) (the *Promotion Period*).
5. To enter, Eligible Entrants must access the Gleam form found at <https://gleam.io/XsNWQ/month-of-free-rentals-competition-february-2020> and complete as many actions as they desire (minimum 1 to be entered to draw). Entries must be received by 5:00PM 29/02/2020 to be eligible to win.
6. Eligible Entrants in the Competition may receive up to 38 entries, if all entry criteria are completed on Day 1 (01/02/2020) and the Free Daily Entry is claimed each day until and including 29/02/2020.
7. The Promoter will require the winner provide proof of identity (specifically proof of state of residence) in order to claim a prize. Results will be published in relevant print or electronic media as required by State law. If state confirmation is not received within 7 days, the winner will be redrawn.
10. The one entry automatically selected at random by Gleam will receive one (1) promotional code, valid for 1 rental per day, valid for 31 days, and valid from the day after the winner has confirmed and proven their state of residence.

12. All prices stated are in Australian dollars, represent the recommended retail price (RRP), include GST and were correct at time of printing. The Promoter accepts no responsibility for change in prize value between the time of printing and the ultimate redemption date of the prize.

13. All references to times and dates if otherwise unspecified are to times and dates in Victoria, Australia (AEST, or AEDT when applicable).
