Terms and Conditions

1. This is a game of skill and chance plays no part in selecting the winner. The Promoter's decision is final and no correspondence will be entered into.
2. Information on how to enter forms part of the Terms and Conditions of entry. Entry into the '*The Great Christmas Giveaway*' Competition (the Competition) is deemed acceptance of these Terms and Conditions of entry.

Entry is open to Australian residents of Western Australia, New South Wales, Northern Territory, Queensland, Victoria, South Australia, Australian Capital Territory and Tasmania, who must be 15 years of age and over (*Eligible Entrant*).
